OAG Auditors..... Taking on the IPSAS and IFRAS journey with pride

In the National Audit House' quest to attain financial and operational independence through the audit bill, it only makes sense that its auditors are ready for the shift.

Financial and operational independence would mean that both the Office and its staff are ready to integrate some of the changes that come with such independence. Therefore, the Office, through its staff development fund is making financial provision for its auditors' professional development which will benefit the audit house in the near future.

The OAG's current entry requirement for an Assistant Auditor position is a Bachelor's Degree on NQF level 7 in Accounting and Finance/Auditing subject to a two year inhouse training program offered by the Office of the Auditor-General. In order for the OAG's auditors to further develop their professional careers, it is advisable that they either follow the ACCA or CA streams. This can be done either through attaining funding from the

OAG or from personal funds, at the discrepancy of the auditor.

The Office of the Auditor-General currently boasts with one ACCA certified auditor as part of its work force as well as 17 others aspiring either toward ACCA or CA in the various stages as well as one middle manager pursuing a CA through the Institute of Chartered Accountants in England and Wales (ICAEW) and the Botswana Institute of Chartered Accountants (BICA). This course consists out of 15 components with a three year article apprenticeship to be completed with a recognized institution.

For you to become a CA you need to have a bachelor's degree in: Financial Accounting, Auditing, Management Accounting/Financial Management or Taxation.

PROFESSIONALIZED...



A degree with these majors will automatically gain you entry into the Certificate in the Theory of Accounting (CTA)/ Postgraduate Diploma in Accounting (PGDA) which is a one-year course. Upon completion of the CTA or PGDA, you are required to write two board exams namely: Board 1: Initial Test of Competence (ITC) as well as Board 2: Assessment of Professional Competence (APC). Successful completion of both board exams will then leave you to completing your Articles also known as a Traineeship from any accredited institution.

The Office currently has 4 auditors who are pursuing their CTA or PGDA. Additional to that, the Office has 2 auditors who have completed their CTA or PGDA and have passed either their first or both board exams and are currently on trainee attachment with accredited institutions. The auditor pursuing CA through (ICAEW) and (BICA), has completed 12 out of the 15 components as well as his 3 year apprenticeship so far and is currently continuing with the completion of the last 3 components of the course in order to be chartered.

The process is different for the Association of Certified Chartered Accountants (ACCA). In order to complete the ACCA Qualification and become an ACCA member, the requirements include that you complete the Applied Knowledge, Applied Skills and Strategic Professional components which include 14 exams. For candidates who have a bachelor's degree from an ACCA accredited institution, some sort of exemption may be offered which may lead you to only complete

the Strategic Professional exam or else you may need to start at the beginning which is the Applied Knowledge exam.

The former exam consists out of 4 exams: Strategic Business Leader and Strategic Business Reporting as compulsory modules; then choosing two further courses from Advanced Financial Management; Advanced Performance Management; Advanced Taxation; or Advanced Audit and Assurance. In addition to the 4 exams, in order to become an ACCA member you will need to complete 1 ethics and professional skills module as well as 3 years work

experience in a relevant workplace. All of this can be obtained in a minimum of three years.

Currently, the Office of the Auditor-General have 4 auditors who have completed all four components of the ACCA qualification and are currently on attachment or seeking approval for attachment, as well as 7 others whom are currently busy with either their Applied Knowledge, Applied Skills or Strategic Professional exams.

In addition to the Office quest to fully professionalise its auditors, it also encourages and support those that want to study specific professional development courses that will enhance their public sector audit ability. Such courses include Certified Institute of Management Accountants (CIMA) courses in Business accounting as well as Certified Fraud Examiner courses.

CIMA Business Accounting courses offer auditors to bridge the digitalization and technology gap within the business accounting sector in especially finance digital strategy or cybersecurity. The Certified Fraud Examiner course on the other hand allow for auditors to gain skills in fraud prevention, detection and investigation. The OAG currently have 6 CIMA and CFE accredited auditors.

During previous audit years, the Namibian Local Authority sphere was not in possession of a workable Financial Reporting Framework (FRF) when submitting financial statements.

Local Authorities each used a different FRF that suited their environment and budget. These FRF varied from International Financial Reporting Standards (IFRS) and the Generally Accepted Accounting Principles (GAAP) and many more. In an attempt to promote a standardized financial reporting framework for local authorities, the Office of the Auditor-General conducted research on the most appropriate FRF to recommend to the line Ministry (MURD) for the adoption by local authorities.

The primary difference between the IFRS and IPSAS is that the former is mostly recommended for bigger institutions whilst the latter is conducive for the public sector. The symbiotic benefit of adopting the IPSAS, ensure that local authorities annual financial statements will be submitted in an audit-appropriate manner which in return lessens the audit process of requesting for the resubmission of financial statements or redrafting.

This fundamental benefit is mostly because the IP-SAS consist of a vast number of accounting standards which audit clients should use to prepare financial

IPSAS statements. have been developed to enhance the quality, consistency and transparency of public sector financial reporting worldwide. Therefore, the International Public Sector Accounting Standards (IPSAS) financial reporting framework was adopted and implemented by all local authorities since 2019 financial year.



In order to build in-house capacity of OAG Auditors in IPSAS, the Office, through its annual training plan, made provision to support 18 financial auditors towards the ACCA IPSAS and IFRS (International Financial Reporting Standards) Certification.

Both courses are a robust online course with assessment in the form of an examination that will lead to certification. The Office hope to enrol a second cohort of approximately 10 financial auditors during the next financial year.

The ACCA qualification is achieved by completing 13 exams over three levels (namely applied knowledge, Applied Skills and Strategic Professional), an Ethics and Professional Skills module and undertaking three years practical work experience in a relevant role. I have nearly completed the Applied Skills level.

Question 2: What benefit will your qualification add to the work of your current position at the OAG and the greater public as a whole?

I believe my qualification will be of great benefit as I am tasked with the overseeing of audit work. In laymen's terms, the audit of state funds provides assurance to the public that tax dollars are correctly accounted for and utilised for their intended purpose. Question 4: Taking your current journey of public auditing into account, what advice do you want to give to other public auditors who are considering professionalising their career as auditors.



OAG COVID-19 VACCINATION CAMPAIGN

Given the implications of the second wave and the underlying dangers of a possible fifth wave, it is extremely important for everyone to get themselves fully vaccinated against Covid-19.



When Covid-19 first hit, it appeared as if the pandemic would be remembered as a brief period of balancing distance learning with remote work and exercising social detachment, and then vanish. However, this was not the case; the virus continued to claim the lives of a number of people throughout the pandemic. Because of our ignorance, the coronavirus spread so quickly that daily case rates in the country quadrupled in a couple of weeks.

OAG'S VACCINATION PROGRESS



Despite the strong covid-19 vaccination campaign by the Human Resource, Wellness division, the office is struggling to increase the vaccination stats, with only 18% of employees at the OAG vaccinated.

The Auditor-General, Mr Junias Kandjeke, and his deputy, Mr Goms Menettè, have both issued recommendations on so many occasions that everyone at the OAG receive their vaccine. The hesitancy to take the vaccine is so rife in the country therefore the OAG's wellness sub division launched a Vaccination Campaign aimed at encouraging people to take vaccines. OAG employees are slowly stepping up to support the Covid-19 vaccination campaign, however the number of vaccinated employees within the OAG remains relatively low. By 31 March 2022, only (40 out of 216) of the staff members within the OAG are fully vaccinated. During the OAG's Recognition Strategy launch last year, the Auditor-General, Mr Kandjeke said that vaccination was voluntary and a personal choice, however he encouraged all staff members to heed the call of government and take the vaccine to increase their chances of fighting the corona virus.

AUDIT PERFORMANCE DURING THE COVID-19 PANDEMIC



Weeks turned into months of extraordinary physiological, economic, and mental devastation as the coronavirus pandemic spread from a handful of outbreak zones to the rest of the country.

Overall, Covid-19 has been a mood-changer for workplaces. The sudden closure of numerous workplaces and working environments these past years introduced an unused time of inaccessible work for OAG auditors; the pandemic has significantly remodeled the culture of work for auditors.

Due to the suspension of face-toface meetings, the OAG was forced to adopt virtual audits, in which auditees were obliged to upload the required documents, as opposed to face-to-face auditing. Most of the audits were done remotely using electronic methods such as video conferencing, email and telephone to obtain audit evidence, mimicking the physical audit process.

This enabled them to be more adaptive to the working from home experience, which is projected to improve the efficacy and flexibility of communication between auditors and the auditees in the long run. Although this exercise yielded fruits, it also method challenges for both the auditors and the auditees. The Director of Cash Based Audits, Ms. Imelda Hummel said that while the institution managed to produce timely audit reports, the pandemic put a severe damper on moods and spirits of auditors and has created anxiety amongst the employees. In terms of information flow, the procedure was not so smooth because access to timely information from auditees were not readily possible.

People could no longer travel from region to region unless they were listed as an essential service provider during the lockdown. As a result, regional audits which were to be conducted on a face-to-face basis were compromised.

Despite these hurdles, the office was still able to explore new prospects such as working from home on a rotational basis, conducting virtual audits, online meetings and interventions, and as a result timely audit reports were produced to the Office statutory deadline. Overall,

With a total of 63 positive cases reported from the Office since the start of the pandemic it has managed to keep a 100% recovery rate through early intervention measures such as office disinfection, provision of gloves, masks and sanitizers to staff, setting up of sanitizer holders at every entrance and exit point of the entire office building as well as training its frontline workers on how to disinfect the office premises.

The OAG employed a Covid-19 Business Contingency plan which allow for the OAG operations to continue as normal under the new normal of the pandemic. This contingency plan is regularly updated with the latest information as regulations are amended by the Ministry of Health and Social Services.

OAG DEVELOPS NEW STRATEGIC PLAN

The Office of the Auditor-General (OAG) Strategic Workshop which took place at Heja Lodge was officially opened by the Deputy Auditor-General, Mr Goms Menettè on the 15th of February 2022.

More than 30 employees from OAG, along with consultants from the Office of the Auditor General of Norway through the INTOSAI IDI, gathered at Heja Lodge for a full week of robust and engaging discussions about a new vision, mission, core values and strategic objectives for the OAG. The Deputy Auditor-General encouraged the workshop members to think of the SAI's independence when creating the 5-year strategic plan, making reference to the review audit bill draft which shapes a huge portion of our vision.

The Workshop which started on Monday, 14 February 2022, was under the direction of the OAG Steering Committee with the assistance in its development process by consultants from Riksrevisjonen Office of the Auditor General of Norway through the INTOSAI IDI. The committee introduced participants to the concept of strategic planning, explaining every component on how we go from a broad vision to a coherent strategy with well-defined objectives and then to a plan of activities that include the kind of services to be offered which are beneficial to the OAG members and other stakeholders.

Facilitators also gave a summary of how the institution performed in the outgoing period, how the institution achieved targets and how far the institution is in relation to its vision. The workshop also formulated new goals and objectives which it wants to achieve in the next five years, some of the critical issues the institution should respond to and the capacity of the institution to achieve the priorities taking into consideration the available resources. This year's theme was 'The year of reimaging'.

At the end of the workshop, the Deputy Auditor-General, Mr Goms Menettè, thanked the Steering Committee and the OAG staff for their contributions towards the 2022-27 Strategic Plan. Mr Menettè also took time to thank the consultants from Norway for the assistance rendered over the years that has enabled the OAG to achieve its objectives. This workshop was concluded on Friday, the 18th of February 2022.

AG ATTENDS A VIRTUAL MEETING WITH THE INCOMING INTOSAI CHAIRPERSON

The meeting was facilitated by Mrs Manuela Faira, who came to Senegal in March 2022, to meet AFROSAI leadership, of which the Auditor-General of Namibia is the current Vice President. The main objective of the International Organization of Supreme Audit Institution (INTOSAI) is to provide assistance to Supreme Audit Institutions (SAIs) in order to work through common challenges related to national governance, and to promote accountability.

The Auditor-General of Namibia, Mr Junias Etuna Kandjeke is a member of the INTOSAI Governing Board, representing Africa since 2019.


The Office of the Auditor-General had the unique pleasure to host the Chairperson of SADCOPAC, Hon.

OAG'S STAKEHOLDER ENGAGES IN OMAHEKE REGION

The Office of the Auditor-General (OAG) through its Public Relations (PR) division has been embarking on regional and rural engagement with the purpose of creating an inclusive and informed opinion from stakeholders.

The office has realized that if they are to succeed in





accomplishing objectives and meet the set targets, it was imperative to get everybody in the institution on board and in tune with the direction it intent to go. It also meant improving services to stakeholders and reducing backlogs. Hence, OAG carried out an intensive engagement throughout the Omaheke region in the 2020 and 2021 financial year. The Regional Stakeholder's Engagement of Omaheke took place from 06 March 2022

to 11 March 2022.

The following towns and settlements were engaged during the said period:

- Omaheke Regional Council
- Gobabis Municipality
- Otjinene Settlement
- Epukiro Village
- Witvlei Village
- Okamatapati Settlement



The office was able to establish the following from regional needs:

- The OAG's core functions and capacities are confused with the work of the ACC, Prosecutor General, NAMPOL and the Attorney General;
- Staff members do not understand their contributions towards the audit process nor the audit opinion;
- The regional offices need to develop asset register:
- Most of the regional offices have no record keeping policy;
- Reasons why they submit their financial statements so late.

The recommendations that came out of the meetings suggested that the office need to engage more and play a role in the process of information sharing, so as to ensure that all stakeholders know what they are supposed to do at any given time during the process of audit. They should know what an audit report looks like, how it impact them directly and indirectly.

OAG employee, Mr. Tuyeni Immanuel has participated in the National Deaf Development Games, which was held in Durban, South Africa, from March 19 to March 20, 2022. Mr. Tuyeni Immanuel's team was unfortunately defeated 4-2 by South Africa in extra time after an extremely tense 1-1 draw during normal playing time.

Tuyeni and co brought home Runners-Up Medals. As an Office that prides itself in employee wellness and support, the office initiated a fundraising initiative that assisted Mr Tuyeni to contribute towards his participation at this prestigious national event.

The Office of the Auditor-General is inclusive in its recruitment policy as well as in adopting in general the enational affirmative action

policy of government by employing persons with disabilities. Mr. Tuyeni forms part of the 3.27% of persons with disabilities currently employed by the OAG. According to the Office's current Affirmative Action Plan, the Office should employ at least 5% of the total staff complement of people living with disability. It is also evident that disability may take different forms ranging from vision impairment, hearing impairement and physical disability inter-alia.

This 3.27% achievement is putting the OAG in a personal leading position with over two-thirds implementation of the legal requirement.

To further demonstrate the OAG's inclusivity toward persons with disabilities, the OAG has made provision through its Training Committee, to allow staff members to undergo a short course on Sign Language. This will help the integrated communication process amongst OAG staff members especially those persons with disabilities and improve functionality. Staff members who are sent on the

course were selected on the basis of diversity representation and also in terms of contact frequency with the hearing impaired staff member.

Currently there are 5 staff members, including the Deputy Auditor-General, attending this 6 month course, after which, the Office will send its next cohort of especially frontline workers. Other significant inclusive approaches from the OAG Affirmative Action Committee include the Office receiving a compliance certificate from the Employment Equity Commission; regular staff awareness on issues of Affirmative Action as well as the Disability Policy being reviewed and approved.

Contrary to this, in its attempt to inclusivity in the workplace, the Office has also approached the Namibian Federation of the Visually Impaired (NFVI) to assist the Office with translating its information booklet into Braille in order to ensure simplified translation of our audit information to diverse stakeholder groups.
