1. METHODS OF EVALUATION AND SELECTION

The bids were examined and evaluated in three (3) stages namely Eligibility Criteria, Qualifying Criteria and Bid pricing Criteria. Through this method technical proposal of all were considered and selected accordingly.

2. BEST EVALUATED BID

On the basis of the evaluation which was carried out it is recommended that the bid be awarded to **Amalinda Trading** which submitted the lowest evaluated substantially responsive bid which meet all the criteria's for the amount of **N\$ 8 118.71** for the supply and delivery of Cleaning Materials to the Office of the Auditor-General for a period of 36 months (3years).
